Galien Township Planning Commission Regular Meeting November 7, 2018 7:30pm @ Galien Township Office Minutes

The meeting was called to order at 7:30pm

Roll Call: Present- L. James, J. Rochman, J. Richter, C. Lorange. Absent- C. Carr

Set/Amend Agenda: J. Richter made a motion to approve the agenda with the addition of 2018-RM Ordinance under New Business. C. Lorange supported. Motion carried. No nays

J. Richter led the Pledge of Allegiance

Approve Minutes: C. Lorange made a motion to approve the minutes from October 3, 2018 as presented. J. Rochman supported. Motion carried. No nays

Public Comments:

Jerry Mast: Jerry offered to work with the data from the census and compile it for the Master Plan.

Savannah Devries: Savannah asked if the Township has ever considered a large clean up similar to what the Village does.

New Business:

2019 Schedule: It was suggested we move the PC meetings to the first Tuesday of the month. We will table until December and make a decision then.

2018-RM: The PC reviewed the proposed ordinance and recommends that the Township Board adopt the ordinance.

Updates:

Master Plan: The PC agreed to accept Jerry Mast's offer to help compile the Census data. After some discussion we think we should try again to partner with the Village. L. James said we need a spreadsheet to track all the tasks associated with the Master Plan. L. James is going to check with Survey Monkey again for costs. We also need to create an agenda for the Master Plan so we stay on track and keep moving forward. J. Richter suggested the PC reach out to Ezra Scott for ideas or suggestions on funding or assistance in creating the Master Plan.

Medical Marihuana: There are 3 documents that need to be combined to make the SUP document complete. C. Lorange will forward notes to J. Richter to compile the information into 1 document. J. Richter to contact Attorney Senica in regards to drug testing in the facilities. Not sure if we
