# **Unfinished Business**

2018 Construction Status Update – Per information from Don Giesler, Mt. Zion will receive 6" of gravel and Olive Branch will receive either 3" or 6" based upon the BCRD's assessment. The Township agreed to pay an additional \$13,200 to have 6" of gravel on Mt. Zion and any additional gravel on Olive Branch will be at the BCRD's expense. Leann questioned whether Mt. Zion was primary at some point due to the macadam base. Jim and Bruce pointed out that the extra gravel helps smooth out the road better than the macadam alone. Don indicated that the goal is to have the first layer of sealcoat put down approximately 2 weeks after gravel is properly compacted, weather permitting. Jerry indicated that he is working on a list of potholes throughout the Township to give to Chuck Palen, which will include the damage on Olive Branch Rd near Rickerman.

Road Plan/BCRD Asset Management Plan – Jerry provided a schedule to project the cash flows of the Township's Road Fund. A small surplus of approximately \$2,200 is projected after paying for this year's work and collecting the 2018 winter taxes.

Paver Patch for 2018 - The paver patch on Second Street near Gardner has been completed.

Nye Road Bridge – MDOT awarded Milbocker and Sons, Inc. the bid for replacement of the bridge at a cost of \$576,850. The work is scheduled to be completed by September 28, 2018.

Olive Branch Road Damage (West of Rickerman) – As noted above, will be included with pothole list.

<u>Spring Creek Flooding Issue (West of Nye Rd)</u> – No update was provided and we will continue to monitor to see if flooding reoccurs.
