# Galien Township Planning Commission Regular Meeting February 5, 2019 7:30pm @ Galien Township Office Minutes

The meeting was called to order at 7:30pm

Roll Call: Present- L. James, J. Rochman, J. Richter, C. Carr, C. Lorance. Absent- None

<u>Set/Amend Agenda:</u> C. Lorance made a motion to approve the agenda with the date change for minute approval to January 8<sup>th</sup>. J. Rochman supported. Motion carried. No nays.

**Approve Minutes:** C. Lorance made a motion to approve the minutes from the January 8, 2019 meeting. J. Rochman supported. Motion carried. No nays.

#### **Updates:**

<u>Master Plan:</u> C. Lorance shared a map that he created to use for the Master Plan showing the lines dividing the township into 4 quadrants. L. James reported that the survey is ready on Survey Monkey. J. Richter shared a letter from Bertrand Township informing us of their Master Plan update.

Medical Marihuana: C. Lorance began a discussion of changing the notification distance for the medical marihuana facilities back to 300 feet. J. Richter shared a letter from Attorney Senica with her thoughts, stating that she felt comfortable with the change back to 300 feet since that is all that is required by State law. J. Rochman stated that she agreed with C. Lorance and Attorney Senica and she thinks that the medical marihuana applicants should be treated like any other business type applying for a SUP. C. Carr thinks we should review the notification distance but does not see the point in making a change at this time. J. Richter stated that she feels the notification distance should be the same for all SUP's but thinks we should make them all 1000 feet instead of using the 300-foot distance required by the State. After much discussion it was decided to add the notification distance as a survey question on the Master Plan survey with the option of 300, 500, 750 and 1000 feet. J. Richter informed the PC of Med Farm of Michigan's request to have a new public hearing to change locations and move to parcel 09-0003-0008-00-2 aka 2211 US Hwy 12. The new public hearing is schedule for March 7, 2019 at 6:30pm.
